CHAPTER 6

TRAFFIC

Section I: (*Signs and Signals*) It shall be unlawful for the driver of any vehicle to disobey the instructions of any traffic sign or signal placed in view by authority of the President and with the advice and consent of the Village Board of Trustees, or in accordance with the laws of the State of Illinois, excepting on direction of a police officer. All signs and signals established by direction of the governing body shall conform to the Illinois Statue Manual of Uniform Traffic Control Devices for Streets and Highways.

Section II: (*Interference with Signs and Signals*) It shall be unlawful for any person to deface, injure, move or interfere with any official traffic sign or signal.

Section III: (*Through Streets*) Streets and parts of streets of the Village designated by ordinance as through streets are hereby declared to be through streets. The driver of a vehicle shall stop at the entrance of a through street and shall yield the right of way to other vehicles which have entered the intersection or which are approaching so close on a through street as to constitute an immediate hazard, unless directed otherwise by a traffic officer or a traffic control signal. The through street(s) in the Village of Cullom are as follows: (a) Jackson Street.

Section IV: (*Reckless or Careless Driving*) It shall be unlawful to operate any vehicle in the Village in a careless, reckless or wanton manner, or carelessly so as to endanger life or property of any person, firm, or corporation, including the life and property of the driver.

Section V: (*Speed Restrictions*) It shall be unlawful to drive any motor vehicle on street not under the jurisdiction of the Illinois Department of Transportation, Illinois State Department of Public Works and Buildings or County, in an urban district within the Village, at a speed in excess of 20 miles per hour, or such posted speeds, or in an alley at a speed in excess of 5 miles per hour unless otherwise posted.

Section VI: (*Screeching Tires – Loud Mufflers*) No person shall drive or operate a motor vehicle upon any public street in the Village of Cullom which will cause excessive or unnecessary noise by the screeching of tires, any unnecessary tire noise, or any unnecessary loud muffler noise.

Section VII: (*Liquor or Drugs*) It shall be unlawful for the user of narcotic drugs to operate any motor vehicle on any Village street and it shall be unlawful for any intoxicated person, or any person under the influence of alcohol or of a narcotic drug to operate or to be in contact to operate, or attempt to operate any motor vehicle on any Village street.

Section VIII: (*Alcoholic Liquor – Possession*) No person shall transport, carry, possess or have any alcoholic liquor in, upon or about any motor vehicle except in the original package with the seal unbroken.

Section IX: (*Penalty*) Any person, firm or corporation violating any provision of this Chapter shall be fined not less than five hundred dollars nor more than five thousand dollars for each offense.
