<u>Minutes:</u> Motion to accept, by consent agenda, the May Regular Board Meeting and the May 25 Ordinance Meeting minutes was made by Meister/Mills. M/C.

Maintenance Report:

- No Solicitor signs have been posted on each end of town.
- Conduit for planting areas on sidewalk project has been completed
- All landscaping for sidewalk project has been completed
- Drainage ditch on south side of village has been cleaned where it enters the tile
- Inquired about solutions for drainage ditch with Epel
- Concrete work within the village has been completed
- Water hydrant at Oak and Hack will be replaced
- Gazebo at Village Park has been landscaped with extra plants from sidewalk project
- July 19 has been set for the date for village clean up day. Dumpster has been ordered
- Spray patching of village streets will be done the week of July 8-14
- Ordinance violations have been delivered
- Motion was made by Wallrich/Krause to have Lovell purchase a push mower with a grass catcher to mow the north side business area grass areas. All voted in favor and M/C
- Reported on problems with the Mag Meter at the Pump House. At present, it is working but will keep a close watch on it

Attorney Report: Gabor reported through email about the village on-going litigations and sent the Prevailing Wage and Trash Ordinances to be approved and signed

<u>Clerk Report:</u> Meister/Mills approved the bills totaling \$113,598.38. All voted in favor and M/C

<u>Treasurer Report</u>: Motion made by Krause/Whitman to accept the Monthly report and to transfer CD #41449 and CD #202260 to the General Fund to defray the cost of the North Side Business Sidewalk Project. All voted in favor and M/C.

Old Business:

- North Side Business Sidewalk Project Left to do is parking striping, railings, a possible problem with cement cracking in front of the library and repair a broken light at the bank. Lovell was instructed to have the south side parking striping done at the same time the north side is striped
- Drain Maintenance Lovell has talked with Epel
- Trash Policy Whitman/Wallrich made the motion to accept Ordinance 2018-C
 (Ordinance Regarding Garbage and Refuse Collection). All voted in favor and ordinance was signed and recorded
- Community Building Property Agreement No action taken
- Ordinance Violations Ordinance violations have been given to offenders. Mills will take

- Krause/Meister made the motion to allow the use of village property for a volleyball tournament during the Cullom Celebration. All voted in favor and M/C

Any Other Business

- The CAB Committee will host a family night at the village park on July 27, 2018
- The Finance Committee will discuss the Appropriations Ordinance at their July 12 meeting.
